TERMS AND CONDITIONS

Please read these terms and conditions carefully. By entering into this Macmillan Education International Curriculum Global Science Competition for World Science Day 2020 ("Promotion"), you agree that you have read these terms and that you agree to them. - 8. Promoter accepts no responsibility for any entries that are incomplete, illegible, corrupted or fail to reach Promoter by the closing date for any reason. Proof of posting or sending is not proof of receipt. Entries via agents or third parties are invalid. No other form of entry is permitted. Please keep a copy of your entry as we will be unable to return entries or provide copies.

- 9. The prize for the Promotion consists of the following: attendance of the winning teacher at the annual Association of Science Education conference in the United Kingdom including return economy class flights to an UK airport from the winner's home airport agreed with us, transfer costs once in London, meals and accommodation provided in the Promoter's chosen hotel for up to 5 nights for the duration of the conference. All other expenses are the responsibility of the winner. Insurance is not included. Entrants must arrange their own travel insurance. Entrants must have a valid passport and visa (if necessary) and be willing to travel for the notified dates of the conference. The winner will be solely responsible at their cost for obtaining the necessary visas to take up the prize. We will not be responsible if a visa is denied or for any costs associated with obtaining a visa. In the event that the Association of Science Education conference does not take place the Promoter will seek an alternative and appropriate conference at their sole discretion. The winning school will receive a half-day 'hands on science' event which will be conducted in the school premises at a time that is convenient to the school before 12 December 2020. This event will consist of the Promoter providing a Science Educator to attend the school and deliver a 2 – 2.30 hour hands-on event which will be interactive and will focus on elements of the primary science curriculum. In the event that for reasons beyond the control of the Promoter, access cannot be obtained into the school or country of the winning school, the Promoter will endeavour to provide an alternative arrangement which will involve the provision of materials for the school to run an in-school event. Further prizes of science resources value less than 100 GBP, certificates and medals will be available to the runners up. The numbers of runners up are at the discretion of the Judges but will be no less than 3 schools and no more than 5 schools.
- 10. The process for selecting a winning entrant will take place in two stages. Stage 1 entrants will send a 3 minute video or presentation in powerpoint or word document of their idea based on solving a problem in world science such as solutions for reducing water or air pollution, treating injuries or diseases, solving the problems associated with plastic pollution, improving efficiency of machines, an innovative way of reducing the impact of fast fashion. These are ideas only and entrants can propose any solution to any problem that falls within the description of a science based solution. The selection criteria will be: cost of implementation and impact, creativity and innovation, methodology and approach, analysis and research. Stage 1 videos and presentations must be submitted no later than 23:59 GMT 31 May 2020. All submitted video entries and presentation entries will be judged by a panel of Springer Nature editors and authors. Stage 2 – the 8 entries that best meet the above selection criteria will be notified by 30 June 2020 by email and the relevant entrants will be asked to attend a webinar where they will be asked to present their model/experiment/idea to a judging panel. This will involve a question and answer session. Full names of the judging panel will be made available upon request. The judges' decision is final and we will not discuss their decision with you.
- 11.
